Upgrades

Accessibility

We rewrote part of the EUR-Lex code to make sure that the website works better with assistive technologies, for example when navigating lists and tables.

Moreover, all images on EUR-Lex now have an alternative text, and carousels can be paused.

Finally, for users of assistive technologies, there will only be one pagination widget on the search results page, making it easier to navigate.

Legally binding printed editions of the Official Journal

Following the amendment of Regulation No 216/2013 on the electronic publication of the Official Journal, the page on the [legally binding printed editions](#) of the Official Journal has been modified. It explains the new rules, and a revamped table gives all the relevant information on these editions.

Consolidated texts
